## TERMS & CONDITIONS

### 2025 WORLD GUARD MEMBERSHIP DUES: \$3,225

The Membership Dues cover the costs associated with supporting the Program. They consist of the following: A World Class Design Team (Program Coordinator, Drill/Stager, Choreography, Graphic Design), Copyright Fees, Sound Design, Instructional Staff, including day school specialist in technique & dance, Competition Fees, Costumes/Uniforms, Cleanings, Props, Equipment, Equipment Truck Cost, School Bus Rentals, 3 day/2 night trip to the Orlando Regional, a 5 day/4 night trip to the WGI World Championships in Dayton, Oh, Official 2025 Show Shirt, and all other costs which support the Program.

**Additional requirements** for all members include participating in the SNAP FUNDRAISER, mandatory program AD FUNDRAISER where each student will be required to sell four \$25 ads for the STONEMAN DOUGLAS WINTER GUARD SHOW PROGRAM as well as have ONE ADULT VOLUNTEER for the Guard Show on February 22<sup>nd</sup>.

### Membership Dues are NON-REFUNDABLE

Winter Guard programs require a non-refundable commitment fee and fair share. All operational costs for these programs are divided equally by the amount of participants. The financial obligation to the parents for each program will be determined prior to the start of these respective programs and consider a predetermined amount of fundraising. The final cost may vary depending on the results of the group's fundraising efforts. Refer to the Marching Eagle Parent Association, Inc.
